#### Membership changes - Important

Commencing with the **2017** membership year which runs from I January to 31 December **Institutional membership** will **no longer be available**.

If you are an Institutional member and wish to continue to be an active member of the association after 31 December 2016, you will need to join IALL for **2017** as an Individual, Retired, or Student member.

The IALL Secretary will send out an announcement for the opening of membership renewals for 2017 in or around November.

**Individual** – Dues US\$95 for North America, EU, EEA, Australia, New Zealand, United Kingdom, Switzerland; Dues US\$60 for All other countries; Benefits:

- Eligible to vote on association matters
- Eligible to serve on the Board and committees
- Eligible for a reduced registration fee for the IALL annual course
- Eligible to apply for Association funded Member-Only bursaries to attend the annual course.
- Receive the International Journal of Legal Information (IJLI)
- **Student** Dues US\$30; Benefits:
  - Eligible for a reduced registration fee for the IALL annual course
  - Receive the International Journal of Legal Information (IJLI)
- **Retired** Dues USD \$45; Benefits:
  - Eligible for a reduced registration fee for the IALL annual course
  - Receive the International Journal of Legal Information (IJLI)

The official journal of the IALL, the IJLI, is now being published by Cambridge University Press (CUP). You may have read Barbara Garavaglia's recent email in which she informed members not only of the changes to membership, as per above, but also that

commencing in January 2017 subscriptions to the IJLI will be made available to people who do not have a membership. With the cessation of Institutional memberships should your institution wish to continue receiving a copy of the IJLI it will need to take out a subscription. CUP commenced sending out renewals in August to all Institutional members current through to 2016.
