President's Report, October 2021 through September 2022

This is my final report to the membership as President of the International Association of Law Libraries covering the period October 2021 through September 2022.

The Board which held office during 2021-22 was constituted as follows, President: Kurt Carroll of the Library of Congress, USA; Vice President: Kerem Kahvecioğlu of the Istanbul Bilgi University, Turkey; Secretary: David Gee of the Institute of Advanced Legal Studies, UK; Treasurer: Barbara Garavaglia of the University of Michigan Law School, USA; Board members: Kristina Alayan of the University of Maryland Francis King Carey School of Law, USA; Rebecca Five Bergstrøm of the University of Oslo Law Library, Norway; Heather Casey of the Library of Congress, USA; François Desseilles of the Court of Justice of the European Union, Luxembourg; Michel Fraysse of the Université Toulouse 1 Capitole Libraries, France; Trung Quach of the High Court of Australia in Canberra, Australia; Jean Wenger of the Chicago-Kent College of Law, USA; and editor, ex officio member: Mark Engsborg, MacMillan Law Library, Emory School of Law, USA.

Two long standing board members, Barbara Garavaglia and David Gee are completing their board terms and have formally retired from their professional positions. We thank them for their service to IALL and welcome them into the ranks of retired members.

The Board met virtually on 3 October 2021 before the annual course presented from Toulouse and on 7 October, immediately after the Toulouse course. Annually returning items were discussed, primary of which was the approval of the association's 2022 operating budget. Individual officers and members of the board took the opportunity to meet on a number of occasions, in particular at the annual meeting of the American Association of Law Libraries in July 2022 and kept in contact throughout the year to discuss issues concerning the association.

I accepted invitations to attend the annual meetings of the American Association of Law Libraries (AALL; in person) and the Canadian Association of Law Libraries (virtual). Vice President Kerem Kahvecioğlu represented the association at the meeting of the British and Irish Association of Law Librarians. At the AALL meeting, I co-hosted the *International Attendees Joint Reception* with AALL and the Foreign, Comparative and International Law Special Interest Section (FCIL-SIS). Reciprocally I have invited the presidents of the American Association of Law Libraries, Australian Law Librarians' Association, British and Irish Association of Law Librarians, Canadian Association of Law Libraries/Association Canadienne des Bibliothèques de Droit, and the New Zealand Law Librarians' Association to our 2022 annual meeting.

This year marked the period for a new board to be elected. A call was made to the membership to form a nominating committee. The committee, approved by the board, was made up of Robin Gardner (Australia), Marci Hoffman (USA), and Silke Sahl (USA). The Nominating Committee worked independently and received board support via the IALL Secretary who served as board liaison. We thank the committee for their thorough, hard work. The election season is tightly scheduled per the IALL constitution. Committee members kept to this schedule, solicited and received nominations, and conducted interviews to produce a slate of candidates that represented the diversity of the IALL membership. Following the election, the Secretary announced the full composition of the new board in May. We thank the Nominating Committee for their dedicated service.

I conclude my report with sincere thanks to all of the Board officers and members for the camaraderie, friendship, and hard work they have shown during my term as President. I wish the incoming Board every success in the governing of the association.

IALL TREASURER'S AGM REPORT 2022 FISCAL PERIOD JANUARY 1, 2021 – DECEMBER 31, 2021

This fund statement reflects the cash receipts and disbursements of IALL for the fiscal period January 1, 2021 through December 31, 2021. The Association retained the independent audit firm of Robinson, Farmer, Cox Associates of Charlottesville, VA, USA, to examine the IALL's financial records and to certify the accuracy of its financial statements and the soundness of its accounting practices. The firm has prepared IALL's required tax forms and filed them with the US Internal Revenue Service. Our financial records for 2021 were reviewed in accordance with auditing standards generally accepted in the United States.

The Association's finances were healthy in 2021. With revenues of US\$61,900 and expenses of US\$25,704, IALL realized an increase in net assets of US\$36,196. IALL's total assets at the end of 2021 were US\$481,339, an increase of approximately 8% over 2020. We ended the year with no liabilities.

IALL, like the rest of the world, continued to experience significant disruptions in 2021 because of the covid-19 pandemic. The rescheduled Toulouse, France annual course was presented as a virtual course as a result. Finances in 2021 continued to be stable despite the disruptions, with unusually low expenses without an in-person annual course. Revenues in 2021 reflect membership dues, virtual course registrations, royalty payments, and minor interest on savings. IALL's asset levels are higher than normal because of few expenses in 2020 and low expenses in 2021. The return to in-person annual courses beginning in 2022 will undoubtedly return expenses to a significantly higher level and will reduce IALL's assets accordingly.

INDEPENDENT AUDITORS' REPORT

**To the Board of Directors

Opinion

We have audited the accompanying financial statements of International Association of Law Libraries (a nonprofit organization), which comprise the statement of assets and net assets—cash basis as of December 31, 2021, and the related statement of support, revenue, and expenses—cash basis for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the assets, liabilities, and net assets of International Association of Law Libraries as of December 31, 2021, and its support, revenue, and expenses for the year then ended in accordance with the cash basis of accounting as described in Note 2.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of International Association of Law Libraries and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of International Association of Law Libraries' internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about International Association of Law Libraries' ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Notes to Financial Statements At December 31, 2021

NOTE 1 - ORGANIZATION:

International Association of Law Libraries (IALL) is incorporated in Washington, DC as a not-for-profit corporation. IALL is a worldwide organization of librarians, libraries, and other persons and institutions concerned with the acquisition of legal information emanating from sources other than from their jurisdictions. The basic purpose of the IALL is to promote on a world-wide cooperative and non-profit basis the works of individuals, libraries, and other organizations concerned with all aspects of legal information, and to facilitate the use of such information.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

IALL prepares its financial statements on the cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Consequently, certain revenues are recognized when received rather than when earned and certain expenses are recognized when cash is disbursed rather than when the obligation is incurred. The statements do not present the overall financial position or results of operations of the Organization.

Cash

IALL considers cash to include cash on hand and cash in savings accounts.

Concentration of Credit Risk

The Federal Deposit Insurance Corporation insures all bank accounts maintained by IALL thereby limiting potential credit risk to balances in excess of \$250,000. As of December 31, 2021, IALL had a \$105,924 uninsured cash balance.

Income Taxes

No provision is made for income taxes in the financial statements since IALL is exempt from federal and state income taxes under Section 501(c)(4). IALL is not classified as a private foundation.

IALL regularly reviews and evaluates its tax positions taken in previously filed information returns with regard to issues affecting its tax-exempt status, unrelated business income, and related matters. Based on IALL's evaluation of its positions relating to any relevant matters, no tax benefits or liabilities are required to be recognized in accordance with FIN 48.

NOTE 3 - FUNCTIONAL ALLOCATION OF EXPENSES:

The costs of providing the various programs and supporting activities have been summarized on a functional basis in the statement of support, revenue, and expenses - cash basis. Expenses are allocated between programs and supporting services based on direct allocation for each category. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

NOTE 4 - ANNUAL CONFERENCE:

The annual conference hosted by IALL was held virtually in 2021 due to the COVID-19 pandemic. In connection with the conference, revenue and expenses for the conference were received and paid through the accounts of IALL as well as through the accounts of the Local Organizing Committee. Due to the conference being held virtually instead of in-person, IALL also received a \$10,012 refund that had been deposited in prior years for the conference venue.

NOTE 5 - LIQUIDITY AND AVAILABILITY OF FINANCIAL ASSETS:

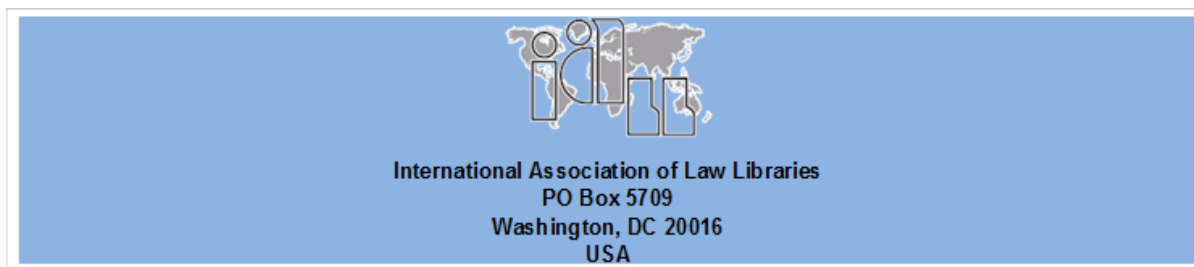
The Organization monitors its liquidity so that it is able to meet its operating needs and other contractual commitments while maximizing the investment of its excess operating cash. The Organization has the following financial assets that could readily be made available within one year of the balance sheet to fund expenses without limitations:

NOTE 6 - SUBSEQUENT EVENTS:

In preparing these financial statements, management of IALL has evaluated events and transactions for potential recognition or disclosure through June 20, 2022, the day the financial statements were available to be issued.

Given the daily evolution of the COVID-19 outbreak and global responses to curb its spread, IALL is not able to estimate the effects of the COVID-19 outbreak on its results of operations, financial condition, or liquidity for future fiscal years.



IALL Finance Committee AGM Report 2022

The Finance Committee chair conferred with the Treasurer via email as needed during the year.

The association continues to be financially stable. Expenses were minimal during 2021 because of the ongoing pandemic and the Toulouse annual course was held virtually. There was a net increase of US\$36,196 for the 2021 fiscal year from membership dues, journal royalties, registrations for the virtual annual course, and interest on savings. There were no bursary expenses for the Toulouse virtual annual course.

Membership: Renewal invoices and renewal reminders for members are sent automatically by the Wild Apricot database and members routinely receive renewal confirmation and payment receipts. Renewal invoices for the 2022 IALL membership year (January 1–December 31, 2022) were sent via email in November 2021.

In 2022, the IALL has 173 members in the following membership categories:

- 137 Individual (North America, the EU, EEA, EFTA, Switzerland, Australia & New Zealand)
- 15 Individual (Other countries)
- 12 Retired
- 1 Student
- 6 Life
- 2 Honorary

IALL members are from 28 different countries, broken down by geographic region as follows:

Communications Committee AGM Report 2022

The IALL Communications Committee provides advice and counsel to the Board of the association and also to the Editor of the International Journal of Legal Information (IJLI) and to the IALL webmaster, while developing communications initiatives and IALL publications.

The Committee's 2022 members are:

- François Desseilles (Court of justice of the European Union), Board Member, Chair
- Rebecca J. Five Bergstrøm (University of Oslo Law Library), Board Member, Blog editor, Sub-committee lead
- Mark Engsborg (Emory School of Law), Journal Editor
- Amy Flick (Emory School of Law), Member at Large
- Kerem Kahvecioglu (Istanbul Bilgi University), IALL Vice President

The Journal editor serves as an ex officio member of the IALL Board. The Committee usually meets during the IALL annual conference (no meeting was held in 2022) and is in regular contact throughout the year via e-mail.

The IALL's webmaster is Michael Lindsey (UC Berkeley Law).

Obviously, the Coronavirus pandemic has affected all our work and activity. The present Communications Committee report is thus shorter than usual as a result. For 2022, the Committee reports the following activities:

I. Follow-up

A roadmap was presented by the chair of the committee to the board in November 2020 to gather proposals to foster the structuration and dissemination of information, pending the drawing up of a global strategy for the development and implementation of the association's missions. It was generally well received, although only a few actions have been taken since then and no concrete action was taken in 2022.

II. Sub-committee

In accordance with our constitution (art. VIII), a sub-committee is in charge of assisting the association in its work to modernise our visual identity, to reshape and revamp the Internet media (website, social media) and implement an Intranet interface for members (in relation to the members' database). The sub-committee is led by Rebecca J. Five Bergstrøm's. Apart from an email sent by IALL President to the board members, nothing has been initiated in this regard (e.g. call to membership).

III. Transmission of credentials

The committee and its chair shall contact its successor as soon as it is appointed by the board, in order to transfer the credentials in the committee's custody (since the current president has taken over some of the communication channels, the committee does not have all the information to pass on).

IV. Blog

One of the committee members, Rebecca J. Five Bergstrøm, has worked hard to keep the association's blog alive with original contributions. Since the last annual course in Toulouse, 4 contributions have been published. IALL blog guidelines have been drafted, loosely based on the *In Custodia Legis* blogging guidelines.

V. Listserv

The IALL members' listserv currently has 664 subscribers (representing an increase of 3.91% since 2021). The listserv has become a supplement to the INT-LAW list for seeking assistance from colleagues around the world for solving difficult reference questions.

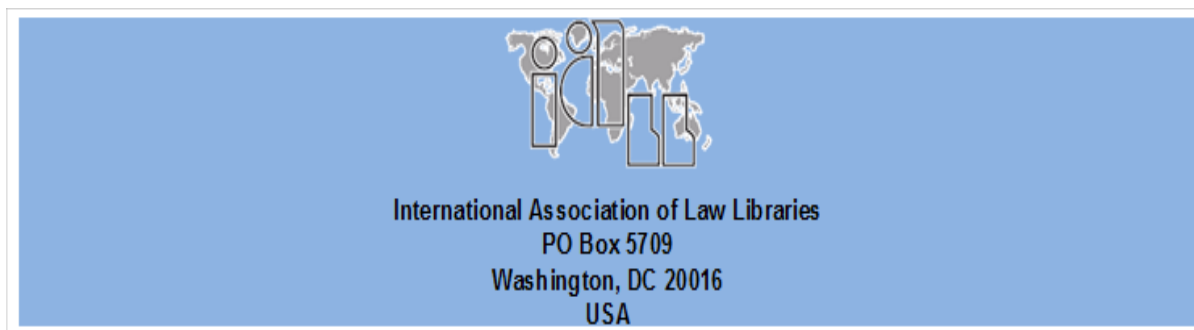
VI. International Journal of Legal Information (IJLI)

The *International Journal of Legal Information* (IJLI) is published by Cambridge University Press (CUP). The latest issue is volume 49 (Winter 2021). No initiative has been taken by the journal editor to support and encourage diversity among editorial board and no action has been taken on previously expressed wishes by the Communication committee to set a volunteer advisory board.

VII. Overall assessment

The activity during the term of office of the committee has been severely affected by the coronavirus pandemic, which is a disappointment to me as Chair of the Committee. I would strongly recommend to the new Board that additional resources are made available for the successful and rapid implementation of the roadmap.

IALL Bursary Awards

IALL awards two distinct types of bursaries to help defray most of the cost of attending IALL's annual course:

1. **Regular Bursaries** which are available to non-members and members; three bursaries of up to a maximum of US\$2,500 each will be awarded.
2. **Members-Only Bursaries** for current Individual members who have paid their dues for the current year and at least the two immediately preceding calendar years; four such bursaries of up to a maximum US\$2,500 each will be awarded.

IALL bursaries are not open to officers or members of the Board of Directors of the Association.

The Scholarships Committee (with the assistance of Michael Lindsey at the University of California, Berkeley) continued to offer the online bursary application forms via the IALL website for both bursaries. The online forms worked well again and the few technical issues that arose during the application period (these were mostly firewall issues) were quickly resolved by Michael Lindsey.

As usual, bursary applications were encouraged and both types of bursary were widely advertised. For example, messages were put up on the IALL Facebook page and on the IALL blog, two encouraging emails were sent to all IALL members and announcements and reminders were sent to a number of regional law library lists by members of the IALL Board.

IALL awarded three **regular professional development bursaries** to attend the 40th Annual Course in October 2022 at Stanford Law School, USA to:

- Rheny Pulungan, Liaison Librarian (Law), Monash University, Australia

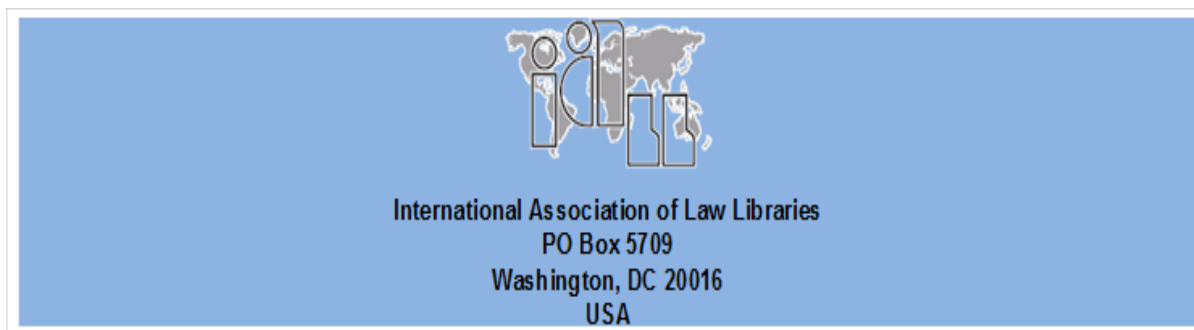

The Education Committee benefits from the opportunity to engage with IALL members in person during the Annual Course. Even without this opportunity to connect in person, the committee participated in developing and coordinating two social events during the online Toulouse Annual Course. These virtual cafés gave participants the opportunity to engage more informally with one another over guided topics of mutual interest. One session focused on literary topics. Attendees were encouraged to discuss and share a favorite book. Conference Committee Report, October 2021 through September 2022

The current members of the Committee are: Kurt Carroll, IALL President and Committee Chair; Kristina Alayan, François Desseilles, Trung Quach, and Jean Wenger.

Last year's Conference Committee report included a prelude to our 39th annual course presented from Toulouse, France. As our first course held exclusively online, no one could predict how successful it would be. Course attendance surpassed all prior IALL meetings. The program continues to reach the law library community thanks to the generous support of Toulouse Capitole University which is hosting the recorded sessions on *Canal U*, <https://www.canal-u.tv/chaines/ut1capitole/iall-2021>. Enthusiasm from the speakers has resulted in article submissions to our *International Journal of Legal Information* (IJLI). Sincere thanks go to board member Michel Fraysse and the members of the Toulouse local planning committee, of which Michel served as chair.

Planning for the 40th Annual Course on International Law and Legal Information at Stanford Law Library began as early as 2019. Beth Williams, Associate Dean at the Robert Crown Law Library, has given exceptional support to the course for which we are most grateful.

A great amount of work has been undertaken by members of the Stanford Local Planning Committee: Taryn Marks (co-chair), Sergio Stone (co-chair), Alba Holgado, Will Huggins, Heather Joy, Grace Lo, Rachel Shields, Katie Siler, Ryan Tamares, and James Thajudeen together with the IALL board liaison, Barbara Garavaglia. No doubt this course will be a resounding success and valuable educational conference.

The 41st annual course is a return to Switzerland, having hosted an IALL meeting in Lausanne in 2001. Following my visit in June, I can attest planning is well underway for our annual course to be held in Geneva in October 2023. A triumvirate of institutions: the Graduate Institute Library, the International Committee of the Red Cross (ICRC) Library, and the UN Library Geneva will present the course. The Local Planning Committee includes Sonia Crenn (ICRC), Charlotte Mohr (ICRC), Clara Kiraly (ICRC), Yves Corpataux (Graduate Institute), and Rachel Forman (UN). Focusing on Geneva's role in multilateralism and international law, the course promises to be a highly enriching experience.

At the time of the writing of this report, the conference committee is reviewing a proposal for the 42nd annual course. It is our hope the full board will be able to review and vote on the proposal at the pre-conference board meeting in Stanford. If approved, the location and institution hosting the 2024 course will be announced at the AGM on 12 October.
